प्रधाचार निरोधक संस्था लोकपाल ने इस साल पई तक मिला 480 शिकायतों का निस्तारण कर दिया है जिनमें से कुछ प्रधाचार से संबंधित नहीं थीं। अधिकारियों ने पंगलवार को बताया कि लोकपाल लोगों को यह सुविध करने की कोशिशो भी कर रहे हैं कि वे उन मामलों की शिकायतें उरुई नहीं भेजे जो प्रधाचार से जुडे नहीं हैं। केंद्र ने अभी लोकपाल को शिकायतें भेजने के लिए एक फॉर्म के संबंध में अधिसूचना जारी नहीं की है। एक अधिकारी ने लोकपाल के आंकड़ों का इस्तेा देते हुए कहा, 'लोकपाल के कावसलव में मिली सधी शिकायतों की खंडनी करने का फैसला किया गया है चहे ने जित्त भी रूप में भेजे गहं हो। 31 मई 2019 तक मिला 480 शिकायतों का निस्तारण कर दिया गया है।' खंडनी के बाद जो शिकायतें लोकपाल के अधिकार क्षेत्र में नहीं आती उनका निस्तारण कर दिया गया और शिकायतकर्ताओं को सुविध कर दिया गया है। लोकपाल राष्ट्रीय खर पर प्रधाचार के मामलों से निपटने के लिए सखीव्य संस्था है। उसे सपरकड उरीके से केंद्र सरकार के सार्जनिक पदाधिकारियों के खिलाफ प्रधाचार के आरोपों की जांच करनी होगी है। लोकपाल ने कहा, 'नागरिकों को सखता हो जारी है कि पंगल, सेना संबंधित पुरी और सार्जनिक शिकायतें संबंधित विधाओं के आधिकारिक पोडरों या सखसखी पर दी जानी चांइए न कि लोकपाल को।' राष्ट्रपि रामनाथ कोविंद ने लोकपाल के अम्यध के उर पर न्यायाधीश पित्तकोर कड मोष को 23 पाच की पद की सपध दिस्ताह थी।
